CMS has launched a new data submission system for clinicians participating in QPP. Clinicians can now submit all of their 2017 MIPS data through one platform on the [QPP website](#).

Data can be submitted and updated any time from **January 2, 2018 to March 31, 2018**. Clinicians are encouraged to log-in early to familiarize themselves with the system.

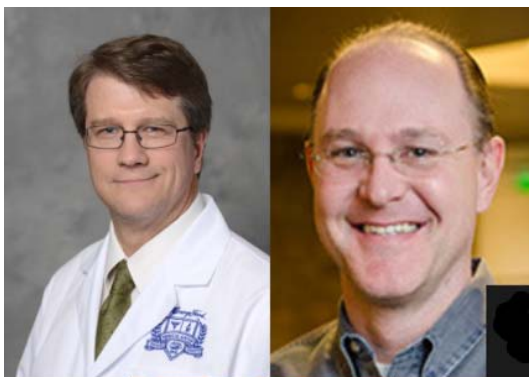
